**028/24 To approve and sign the Minutes of the March meeting:** Minutes were approved and signed by Cllr Cornmell.

# 029/24 To discuss any matters arising from the Minutes of the previous meeting that are not elsewhere on the Agenda:

- i. Jubilee Wood update: the water is slowly dispersing. The area will need tidying up once the water has gone. There are a large number of birds now appearing which is resulting in them 'fighting' over the bird boxes. The entrance to the wood has improved with the laying of churned up quality bricks but more is required. ERYC has promised some hardcore but this has not arrived. It will be mentioned to ERYC officers on the Village Taskforce Walkabout. SJ
- ii. Notice Board update: Cllr Shervington has this in hand. PS
- iii. Langrickgate deferred to next meeting
  - Verges ERYC will be asked to cut the vegetation back by 3ft and on the corners so as to improve visibility for motorists.
- iv. Engagement with the Local Community: Newsletter/Emails Cllr Jones confirmed that the new website has now been built. He will send a link to the Parish Councillors so they can confirm that they are happy with the design. Councillors will review the 6-8 pages which need updating. Up-to-date photography will also be required. Online training and help for the administrators will be provided. It was agreed that Cllrs Jones and Parapen should act as administrators as well as the Clerk. Cllr Stevens will organise drops onto Facebook. There will be a leaflet drop informing parishioners of the new website and an article will be put in the Parish Newsletter.
- v. 80<sup>th</sup> Commemoration of D-Day: the Parish Council has been awarded a grant of £500 from ERYC to help fund the event which is being organised by members of the Feast Team and the Church Team. ERYC has changed the system in that funding will now be issued on submission of expenditure receipts. Cllr Stevens and the Clerk will liaise with the organisers. It is expected that there will be day and evening celebrations with the beacon being lit by Mr Peter Rhodes at 9.15pm as part of the National Lighting of the Beacons.
- vi. Road Sign: Redcap Lane update: although this has been reported to ERYC Highways, they have failed to do the repairs. This will be chased via Cllr Hammond. **YE**
